# Introduction

---

At the halfway mark of the 2030 Agenda for Sustainable Development, compounding crises marked by geopolitical tensions, conflict, and increasingly visible and devastating impacts of climate change, threaten the prospect of making the Sustainable Development Goals (SDGs) a reality. In this context, water action must become a catalyst for progress across the 2030 Agenda. Through its central role in climate, energy, cities, the environment, food security, poverty, gender equality and health, water and sanitation can be an accelerator of sustainable development across our societies.

Yet, today a quarter of the global population – 2.2 billion people – use unsafe drinking water sources, and 3.5 billion people live without safely managed sanitation. Over 40 per cent of household wastewater is not treated properly, damaging ecosystems and human health. Water-related disasters have dominated the list of disasters over the past 50 years and account for 70 per cent of all deaths related to natural disasters. With growing populations, increasingly water-intensive agriculture and industries, and worsening climate change in “the era of global boiling”<sup>1</sup>, guaranteeing a well-functioning water cycle for all people everywhere is essential to ensure human health, environmental integrity and a sustainable, equitable future.

The midterm comprehensive review of the implementation of the International Decade for Action, ‘Water for Sustainable Development’ 2018-2028<sup>2</sup>, or United Nations (UN) 2023 Water Conference, which was co-hosted by the governments of the Netherlands and Tajikistan and took place in New York on 22-24 March 2023, provided a fresh vision of hope and cooperation, gathering governments, businesses, youth, women, indigenous representatives, civil society and academia behind an ambitious Water Action Agenda, including over 800 voluntary commitments to date. As such, it was the most important water-related event in nearly 50 years. It was an unprecedented watershed moment for the international community that recognized the global water cycle as a global common good, and included the United Nations Secretary-General’s considered appointment of a Special Envoy for water as one of its outcomes.

Guided by the United Nations Secretary-General’s vision in *Our Common Agenda*<sup>3</sup> and by its [2030 Strategy](#), UN-Water, as the United Nations’ coordination mechanism for all freshwater-related issues including sanitation, is a key player in the 2030 Agenda and for the United Nations 2023 Water Conference and Water Action Agenda follow-up and implementation. UN-Water is the ‘one voice’ of the United Nations system on all water and sanitation-related issues, it is responsible for the monitoring and reporting of SDG 6 and, through the UN-Water Chair’s action

and the global campaigns (World Water Day, World Toilet Day and the Water Action Decade 2018-2028), it strengthens the global water agenda, aiming for positive returns on health, poverty reduction, gender equality, environment, sustainable development, climate change resilience and security, food and energy security, transboundary cooperation, and greater civic space and partnership.

UN-Water's overarching focus in the 2024-2025 biennium is to support the follow-up to the United Nations 2023 Water Conference and to accelerate progress on SDG 6 through its Members and Partners and in support of all United Nations Member States.

UN-Water will do so through its three main lines of work, identified as areas where it best complements and adds value to the activities of its Members and Partners by facilitating synergies and joint efforts:

1. Informing policy processes and addressing emerging issues.
2. Supporting monitoring and reporting on water and sanitation, including through more disaggregated data.
3. Building knowledge and inspiring people to take action.

This Work Programme presents UN-Water's action in 2024-2025 and is divided into three parts:

1. UN-Water's strategic outlook.
2. UN-Water's expected results in 2024-2025.
3. An overview of UN-Water and its governance structure.

The Results Matrix, the Indicative Budget, a list of UN-Water Members and Partners, a list of UN-Water donors and a list of the acronyms used are included as annexes.

# Part 1 Strategic Outlook

---

The United Nations 2023 Water Conference was the most important water-related event in nearly 50 years. It brought political leadership, concrete actions and cooperation from all stakeholders to address the global water challenges and increased political attention and public awareness to mobilize water action.

The Conference process has changed how water is prioritized and addressed holistically at the global, regional and national levels. Using the political momentum created by the Conference, we now need to mobilize action across countries, sectors, and stakeholders, pour in more funds, fill the data gaps, invest in the water and sanitation workforce, boost innovation and maximize cooperation.

## Theory of change for the UN-Water Work Programme 2024-2025

Securing a sustainable water future and ensuring that SDG 6 delivers positive returns across the 2030 Agenda depends on our ability to guarantee adequate, efficient, effective, and economic allocation and use of water resources across all actors and sectors. This in turn requires policy coherence on water at all levels and a step change in the way the United Nations system prioritizes and mainstreams water into its work and across intergovernmental processes.

The United Nations 2023 Water Conference is a milestone towards strengthening the United Nations system's efforts on water and sanitation. The [SDG 6 Synthesis Report on Water and Sanitation 2023](#) presents the joint vision and response from the United Nations system and its partners on the way ahead following the

Conference. It puts forward recommendations (see below Figure 5 of the SDG 6 Synthesis Report 2023) to ensure elevated, mainstreamed, coordinated water action in the United Nations system, including: the mainstreaming of water in all relevant intergovernmental processes, regular intergovernmental meetings on water, a dedicated system-wide water and sanitation strategy, and a strengthening of United Nations agencies' water and sanitation programmes as well as the centre of coordination.

To support the realization of this vision, the following steps are required and inform the UN-Water Work Programme 2024-2025:

**1. Strengthened support at the top of the United Nations system.** Concretely in the Work Programme, it translates into:

- a. UN-Water Meetings at the United Nations Executive Heads level.
- b. Development and implementation of a United Nations system-wide strategy for water and sanitation, based on the SDG 6 Global Acceleration Framework.
- c. Coordination activities, including Task Forces and Expert Groups, prioritizing and upscaling water and sanitation programmes, including adequate allocation of resources internally in the United Nations system.

**2. Strengthened coordinated action from UN-Water Members and Partners,** including through dedicated human and financial resources among UN-Water Members. Concretely in the Work Programme, it translates into:

- a. Coordination of activities related to SDG 6 Global Acceleration Framework and Water Action Agenda implementation and follow-up.




Figure 1: Options for how the United Nations system can support SDG 6 progress acceleration.

- b. Coordination of activities related to mainstreaming water across relevant intergovernmental processes.
- c. Additional resources for effective country-level and regional-level coordination interface.
- d. Leveraging new alliances and partnerships across all relevant sectors and stakeholders.

**3. Strengthened centre of coordination**, including UN-Water's resources to support the United Nations system's strengthened capacity to deliver results. Concretely in the Work Programme, it translates into:

- a. Strengthening technical/political coordination and outreach capacity of UN-Water.

## UN-Water's focus in 2024-2025

During this biennium UN-Water's response and focus will be:

1. Transforming the SDG 6 Global Acceleration Framework into a United Nations system-wide strategy for water and sanitation, to operationalize inter-agency coordination for SDG 6 acceleration.
2. Ensuring the successful implementation and follow-up to the United Nations 2023 Water Conference and Water Action Agenda.
3. Mainstreaming water in all relevant intergovernmental processes, by integrating water into the agendas of global, regional and national efforts on climate change, health, biodiversity, food, energy, and disaster risk reduction, among others.

UN-Water focuses its interventions at the level of the United Nations family and demonstrates that the sum of its work is greater than its parts. UN-Water adds value by mobilizing global, regional, local and people action, by working across and interlinking different sectors, and by supporting the reform of the United Nations Development System, specifically providing technical assistance to the United Nations Resident Coordinators and Country Teams. As highlighted in the [UN-Water 2030 Strategy](#) and in its [Terms of Reference](#), three lines of work guide UN-Water's actions, to ensure that UN-Water focuses its resources to where it has the greatest impact:

- 1. Informing policy processes and addressing emerging issues** (Results Area 1) – for example, by providing consolidated and coherent policy advice and technical input to inform decision-making at national and international levels.
- 2. Supporting monitoring and reporting on water and sanitation** (Results Area 2) – for example, by providing an integrated framework for monitoring and reporting on water and sanitation in the 2030 Agenda.
- 3. Building knowledge and inspiring people to take action** (Results Area 3) – for example, by raising awareness and sharing lessons learned on the importance of water and sanitation through the campaigns for the United Nations international observances World Water Day and World Toilet Day, and the Water Action Decade 2018-2028.




Figure 2: Theory of Change.

# Part 2

## UN-Water

# Results Areas

## 2024-2025

---

UN-Water's work is organised around four Results Areas. They are seen as areas where UN-Water, as a collective body, can add value to the activities of its Members and Partners and, by extension, to United Nations Member States. The UN-Water Results Areas are presented below, together with their expected outcomes, main activities and outputs. Their full description can be found in the Results Matrix in Annex 1 and their Indicative Budget in Annex 2. The first three Results Areas each contribute directly to the three outcomes identified in the [UN-Water 2030 Strategy](#), while the fourth Results Area ensures agile and collectively owned UN-Water operations.

### Results Area 1 Informing policy processes and addressing emerging issues

*Outcome: Enhanced capacity of the United Nations system to respond systematically, collectively and in a timely way to Member States' requests, providing technical input to policy processes and addressing emerging issues.*

Member States are increasingly turning to UN-Water for consolidated expertise of the United Nations system to support water-related policy processes. For this reason, UN-Water has identified a need to work

more proactively on identifying emerging issues, to inform policy processes and develop collaborative response options.

#### Main Activity 1.1 Providing substantive input to and participating in relevant policy processes and events

UN-Water is facilitating the coordinated engagement of the United Nations in relevant water and sanitation-related global processes including, during this biennium, the follow-up to the United Nations 2023 Water Conference. During the biennium, related activities include the development and implementation of the United Nations system-wide strategy for water and sanitation, based on the SDG 6 Global Acceleration Framework, and the support to the United Nations Special Envoy for Water, when appointed. UN-Water supports relevant processes by providing substantial inputs, either as a convenor, through cross-sectoral engagements or through its periodical assessments or tailor-made reports. It enables a more coordinated contribution of United Nations bodies and actively promotes the role of the United Nations family in solving global water and sanitation challenges, for example by producing joint policy recommendations to Member States.

#### Main Activity 1.2 Country and regional level engagement

UN-Water has identified the need to enhance and upscale country-level support and engagement to implement SDG 6, including through the regional Issue-based Coalitions and by providing dedicated technical assistance to the United Nations Resident Coordinators and Country Teams for the operationalization of the SDG 6 Global Acceleration Framework and

implementation of the Water Action Agenda and United Nations system-wide strategy for water and sanitation, for example through the SDG 6 Capacity Development Initiative and the SDG 6 Country Acceleration Case Studies. In line with the United Nations reform and the Secretary-General's *Our Common Agenda and Call to Action for Human Rights*, UN-Water will further integrate human rights in its work through the implementation of a human rights roadmap, and contribute to the realization of the human rights to safe drinking water and sanitation, including in the context of humanitarian crises, with particular focus on gender equality and leaving no one behind.

### **Main Activity 1.3 Addressing emerging issues**

To identify and address emerging issues and stimulate forward-looking discussions, UN-Water produces analytical briefs highlighting implications across sectors. These briefs address 'new' issues and review trends related to existing challenges.

### **Main Activity 1.4 Providing technical input to the Inter-agency and Expert Group on SDG Indicators (IAEG-SDGs)**

The Member State-led process of developing an SDG indicator framework has highlighted UN-Water's ability to consolidate technical input from the United Nations family and to respond systematically, collectively and in a timely way to the many requests coming from the Inter-agency and Expert Group on SDG Indicators (IAEG-SDGs) and the United Nations Statistics Division (UNSD).

### **Main Activity 1.5 Supporting Results Area 1**

The UN-Water Technical Advisory Unit is part of the UN-Water Management Team and supports and facilitates all UN-Water operations.

### **Results Area 2 Supporting monitoring and reporting on water and sanitation**

*Outcome: Coherent and comprehensive monitoring and reporting systems in place and widely recognized to deliver a sound basis for decision-making at the global, regional and national levels.*

One of UN-Water's key functions is to provide coherent and reliable data, information and assessments on water-related trends and management issues. UN-Water is therefore providing the coordination platform to its Members' initiatives, mechanisms and programmes that collect data and information on the various components of the water cycle.

In this context, the UN-Water Integrated Monitoring Initiative for SDG 6 (IMI-SDG6) harmonizes monitoring efforts into a coherent monitoring framework for consolidated SDG 6 progress reporting. It provides the coordination platform across SDG 6, bringing in and linking the experience and expertise of the WHO/UNICEF Joint Monitoring Programme for Water Supply, Sanitation and Hygiene (JMP), UN-Water Global Analysis and Assessment of Sanitation and Drinking-Water (GLAAS), FAO AQUASTAT, UNEP GEMS/Water, the Transboundary Waters Assessment Programme, the reporting under the Convention on the Protection and Use of Transboundary Watercourses and International Lakes, and the global reporting on Integrated Water Resources Management.

IMI-SDG6 also collaborates with other UN-Water Members and Partners who have data sets that contribute to the global indicators.

The analysis and reports generated by the IMI-SDG6 will serve as a mechanism for identifying emerging issues which can be brought to the attention of the UN-Water Members and Partners for wider consideration.

### **Main Activity 2.1 Engaging Member States and enhancing national capacity to collect, analyse and report data on all SDG 6 global indicators**

Credible water sector data underpin advocacy, stimulate political commitment, inform decision-making at all levels and trigger well-placed public and private investments towards optimum health, environment and economic gains. Member States are the main beneficiaries of improved access to and availability of high-quality data and any monitoring initiative must therefore be sensitive to national needs. To ensure the sustainability of monitoring systems and processes at this level, a strong focus on capacity development is necessary, as well as joint advocacy efforts to highlight the benefits of monitoring and to promote a human rights-based and gender-contextualized approach to data collection and monitoring.

### **Main Activity 2.2 Enabling policy- and decision-makers at all levels to draw upon the interdependencies between and beyond SDG 6 targets and maximize benefits of water and sanitation monitoring data in a holistic manner**

In the framework of the UN-Water IMI-SDG6, the indicators' custodian agencies provide support to Member States for the purpose of reporting on water and sanitation in the 2030 Agenda, aimed at informing policymakers about the status of water and sanitation-related goals and targets as a means of boosting implementation. The SDG 6 Data Portal is UN-Water's collective repository and analysis of SDG 6 data.

### **Main Activity 2.3 Delivering the United Nations World Water Development Report**

The United Nations World Water Development Report (UN WWDR), published by UNESCO on behalf of UN-Water, is the reference publication of the United Nations family, released on an annual basis and based on the theme of World Water Day. The UN WWDR is the result of strong collaboration among UN-Water Members and Partners and represents the coherent and integrated response of the United Nations family to water-related issues and emerging challenges.

### **Main Activity 2.4 Supporting Results Area 2**

The UN-Water Technical Advisory Unit is part of the UN-Water Management Team and supports and facilitates all UN-Water operations.

## **Results Area 3 Building knowledge and inspiring people to take action**

*Outcome: Building on the efforts of UN-Water Members, Partners and other key stakeholders, coherent and coordinated outreach activities and products delivered and promoted to mobilize the public sector, civil society, the private sector, Member States including sub-national governments, the media and youth to take action, with particular focus on leaving no one behind.*

The objective of these activities is to increase the impact and effectiveness of UN-Water's communication and awareness raising activities and materials by making more information accessible, effectively disseminating the information to the target audiences, engaging with a wider range of stakeholders and contributing to a more coherent and coordinated United Nations involvement in major activities and international conferences.

### **Main Activity 3.1 Supporting the International Decade for Action, 'Water for Sustainable Development' 2018-2028**

As per General Assembly resolution 71/222, Member States decided to proclaim the period from 2018 to 2028 the International Decade for Action on 'Water for Sustainable Development', to commence on World Water Day, 22 March 2018. In the same resolution, UN-Water, as part of its core mandate, is requested to support the Secretary-General in planning, organizing and implementing the Decade. UN-Water serves as the United Nations family's coordination platform for the Decade and it plays a critical role in supporting the follow-up to the United Nations 2023 Water Conference.

### **Main Activity 3.2 Maintaining a knowledge hub on water and sanitation**

UN-Water aims to be the first point of contact when stakeholders at all levels require the most up-to-date thinking on water-related issues, channelling inquiries to the relevant UN-Water Members or Partners where appropriate. This activity covers the consolidation and provision of UN-Water expertise online.

### **Main Activity 3.3 Delivering and supporting global campaigns and activities**

Each year, UN-Water is responsible for organizing and creating the campaign materials and acting as the coordination platform for the United Nations international observances of World Water Day and World Toilet Day. The increased attention on social media to these two observances during recent years illustrates that the impact of a coordinated and aligned communications effort can indeed be greater than the sum of many uncoordinated efforts.

### **Main Activity 3.4 Strengthening the UN-Water corporate brand**

UN-Water corporate branding of its products is important to visually show the 'one voice' of the United Nations on water issues. This activity covers the production and dissemination of UN-Water communication materials, outreach and support to a wide range of stakeholders, including the media, and the branding of other UN-Water products such as policy briefs, analytical briefs, annual reports and other governance documents.

## **Main Activity 3.5 Supporting Results Area 3**

The UN-Water Technical Advisory Unit is part of the UN-Water Management Team and supports and facilitates all UN-Water operations.

## **Results Area 4 Effective management of efforts aimed at improved coordination and coherence among UN-Water Members and Partners at all levels**

*Outcome: An efficient, non-bureaucratic mechanism providing value added support to Members and Partners and contributing to the positive impact of United Nations family operations on water-related issues.*

The objective of these activities is to provide the operational and institutional support to all other areas of work. The presence of an efficient and non-bureaucratic mechanism is an indispensable success element of UN-Water.

## **Main Activity 4.1 Improving coordination and coherence among UN-Water Members and Partners**

The biannual meetings of UN-Water function as the main decision-making fora, also providing an opportunity for Members and Partners to share information on their activities, debate challenges and look ahead to emerging issues. In between the meetings the UN-Water Joint Steering Group (JSG) steers the operational management of UN-Water, with specific oversight and management of the UN-Water Inter-Agency Trust Fund. UN-Water reports

regularly on its activities to the High Level Committee on Programmes (HLCP) and to the United Nations System Chief Executives Board for Coordination (CEB). The UN-Water Chair is a United Nations Executive Head and member of the CEB. The online UN-Water Inventory is an up-to-date tool to share information on ‘who does what’ among the UN-Water Members and Partners on water and sanitation-related issues.

## **Main Activity 4.2 Ensuring effective management**

The UN-Water Inter-Agency Trust Fund is administered by the United Nations Office for Project Services (UNOPS) Geneva office. This activity covers UNOPS’ direct support costs to manage the Trust Fund. During the biennium, an additional trust fund will be set up to ensure operational continuity. This activity also covers the development of the UN-Water Work Programmes themselves, which describe the UN-Water activity plan and budget and provide the accountability framework through the use of a Results Matrix. UN-Water also prepares UN-Water Annual Reports as a means of enhancing transparency and providing information on UN-Water’s activities and as its yearly narrative reporting to donors. During the biennium, the mid-term review of the UN-Water 2030 Strategy will be carried out.

## **Main Activity 4.3 Supporting Results Area 4**

The UN-Water Technical Advisory Unit is part of the UN-Water Management Team and supports and facilitates all UN-Water operations.

# Part 3 An Overview of UN-Water's Governance

---

## UN-Water – a brief introduction

UN-Water is the mechanism that coordinates the work of the United Nations on water and sanitation. It was formally established in 2003, building on a long history of collaboration within the United Nations. UN-Water is comprised of the United Nations entities that have a focus on, or interest in, water-related issues as Members and other international organizations as Partners.

UN-Water complements and adds value to existing programmes and projects by facilitating synergies and joint efforts, so as to maximize United Nations family-wide coordinated action and coherence, and to reduce overlap and duplication. By doing so, UN-Water seeks to increase the effectiveness of the support provided to Member States in their efforts towards achieving international agreements on water. Examples of such agreements include the 2030 Agenda on Sustainable Development and SDG 6 on water and sanitation, the Paris Agreement under the United Nations Framework Convention on Climate Change, and the Sendai Framework for Disaster Risk Reduction.

In order to carry out the work along its three main lines (please refer to Part 1), UN-Water's activities are organized around Expert Groups, Task Forces and other Initiatives. The Expert Groups, each focusing on a cross-cutting issue

in need of coordination, gather technical experts from across the United Nations family and other international organizations and represent the United Nations' collective expertise on the given issue. The Expert Groups provide a platform to exchange information, knowledge and experience, to cross-fertilize activities of individual agencies and avoid duplication. Task Forces are time-bound in nature and focus inter-agency collaboration on the delivery of a specific product (e.g. a report or an event).

## UN-Water's Terms of Reference

The scope of UN-Water's work encompasses all freshwater-related matters, including sanitation. It includes surface and groundwater resources and the interface between fresh- and sea water, and freshwater resources in terms of their quality and quantity, their development, assessment, management, monitoring, and use (including, for example, domestic uses, agriculture, and ecosystems requirements). The scope of work related to sanitation encompasses both access to and use of sanitation by populations and the interactions between sanitation and freshwater. UN-Water's scope of work further includes water-related disasters, emergencies and other extreme events and their impact on human security. UN-Water's Dos and Don'ts is an annex to the UN-Water's Terms of Reference, further clarifying which activities UN-Water should (and should not) engage in. For example, UN-Water should not implement projects and activities as if UN-Water were an independent organization

separate from the UN-Water Members; neither should it become a financing mechanism for projects of its Members and Partners.

## Organization and governance

UN-Water is a coordinating mechanism rather than a formal organization, and its activities are primarily implemented through its Members and Partners. The UN-Water Senior Programme Managers (one representative per UN-Water Member) are the decision-making body of UN-Water. The daily operations of UN-Water are run by the UN-Water Management Team composed of Chair, Vice-Chair, Secretary and a Technical Advisory Unit. The UN-Water Joint Steering Group (composed of Chair, Vice-Chair, Secretary and four rotating UN-Water Senior Programme Managers) serves as a forum to steer the operational management of UN-Water.

Since 2012, the UN-Water Chair is a United Nations Executive Head, increasing UN-Water's outreach capacity inside and outside the United Nations.

## UN-Water Members

The Members of UN-Water are the United Nations agencies, funds, programmes and conventions that include water as part of their mandate. In addition to their steering function for UN-Water as a whole, Members are the primary means of implementation of UN-Water's mandate.

## UN-Water Partners

The Partners to UN-Water are organizations from the public and private sectors and civil society that are active in UN-Water's scope of work. Partners take an active role in UN-Water Meetings, engage in Expert Groups and Task Forces and provide support to specific activities.
